President's Report:	D. She thanked M. Edwards for her nomination for the Al Hawk Award, it meant a lot to her and was a wonderful evening. She stated that the tour of the Elementary building and the Natatorium were in acceptable condition.
Principals' Comments:	 S. Bradley reported: Student Council kicked off their Spirit Week last Friday. Saturday, September 28th they had a Homecoming Dance, and had a great turnout with about 100 students attending. The dance was only offered to students in grades 9-12. The dress up days were Monday – Manic Monday (Crazy Hair/Crazy Clothes, Tuesday – Tye Dye Tuesday, Wednesday – Athletic Day, Thursday – Throwback Thursday (dress as your younger self), Friday – Maroon and Gray. The Pep Rally will be held on Friday, October 4th.

	 The students and staff have had a lot of school spirit and he thanked Donna and Alana for all their hard work. Today the Rochester Area Colleges (RAC) hosted a college fair inside the High School and had about 14 different colleges attend. Students in grades 9-12 were able to take advantage of this opportunity. The Instructional Coaches, Debbie and Diana, along with Rebecca leave this weekend for a conference in Kansas City.
	 B. Meister and B. Brown reported: Open House went very well and was well attended. Debbie Slocum has everyone but three teachers participating in the Instructional Coaching model. The Safety Team met on Wednesday morning, and discussed Fire Safety Week next week. They tailored the assembly more to the younger students. The three local fire departments are planning on coming in to help with demonstrations. They had the rooftop photo done on Tuesday, September 24th, and they tried something new this year and did a rainbow. The Board was showed a sneak peak and it turned out great.
	 T. Schulte reported: He thanked everyone for all their support towards his new career. On the Superintendent's Conference Day, October 11th, the technology group will be presenting on technology awareness and what is new and upcoming.
Director Of Instructional Services Comments:	R. Manfreda reported the Response to Intervention plan was shared with the Board for their review. For the next Board meeting the Response to Intervention will be up for approval. On the conference day on October 11 th there will be rollout and overview of the Every Student Succeeds Act (ESSA).
Business Administrator Comments:	L. Prinz thanked Gretchen and the bus drivers for making a video talking about the importance of stopping at a bus stop sign. This week several drivers reported vehicles running through the stop signs at a bus stop. On Tuesday, October 1 st , they held interviews for the Transportation Coordinator position and are hoping to have an appointment up for approval at the next meeting. The Audit Committee met and the District had a "pretty boring year."
Reports:	State of Special Education – Principals/Assistant Principals/Director of Instructional Services R Manfreda gave an update on the District as a whole regarding the Special Education Program. The goal of the District's Special Education Program is to maximize the academic and functional achievement of all

students with disabilities. She listed the objective that will help guide the program's practices. She talked about the blueprint for improved results for students with disabilities. She went through the overview of updated special education data from 2016 to current; there has been a gradual decline in numbers, which is what we should be seeing. Students are being properly classified and given the services they need. In the Elementary School, B. Meister talked about how the teachers are committed to administering and analyzing reading benchmark assessments by the Fountas and Pinnell model. Professional development will be given to the special education teachers that will be focused on effective reading instruction. In the Jr./Sr. High, S. Bradley stated that they are using the Consultant Teaching Model for grades 7th through 9th. In the Special Education Department meetings their main focus will be on IEP goals and progress monitoring.

Academic Focus: Diane Taylor and a few of her 5th grade students came to talk about their STEAM visit to RIT. The students were broken up into small groups and toured the campus. Students learned about many different majors, extracurricular activities, and sports that are offered at RIT. They saw things like a 3D printer that was big enough to make furniture, a plant wall that provides fresh air for the entire building, they used electrolytes from food to make circuits, and built structures strong enough to hold a brick. One of her favorite quotes from a student was "Mrs. Taylor, I never wanted to go to college until today. Now I definitely want to go."
