**Academic Focus:** 

Deb Best and two students came in to talk about the Junior Banking Program (Buzzy Bee Branch – Tonawanda Valley Federal Credit Union). This is a partnership between TVFCU and Byron-Bergen where it helps students gain a financial education and combines hands-on experiences with life skills necessary for the future. Selected students come in once a week for the banking program so that members can bank without going to the main branch. The student tellers must maintain confidentiality and adhere to credit union policies and procedures. This program is available to 4<sup>th</sup> graders only. There are four different jobs at the branch: president, teller, auditor, and treasurer.
