### SUPERINTENDENT'S MESSAGE

I would like to take this opportunity to thank all of the members of the Byron-Bergen learning community who took time to share their input with the Board of Education and myself in the creation of next year's budget. This information was very helpful. We provided the community with an on-line survey and held public presentations on March 16 and April 4. Other data sources guiding the development of the budget

included the Board of Education, the District's Strategic Plan, the District Goals, and our Mission and Vision statements.

It is evident Byron-Bergen is a community that cares greatly about the education of its students. We will continue to put information about the budget on our website. Our goal is to make the budget process as transparent as possible. Within this newsletter, you will find specific information about the proposed budget for 2017–18.

The Board of Education's directives were very clear – develop a spending plan that does not exceed the tax cap and that builds for the future of the Byron-Bergen Central

School District. The 2017–18 proposed budget is \$22.76M. This represents a decrease of 0.47 percent from last year's budget. This budget will support existing programs and people for the next school year, and most importantly, builds for the future. The 2017–18 Budget includes the addition of:

- Equipment and textbooks for the music department
- Driver Education program
- Athletic trainer
- Bus replacement of four vehicles
- Restoration of 1.0 FTE instructional position

It also includes reductions of:

- Maintenance costs
- Central Office services
- Debt services
- Retirement contributions

This budget stays within the allowable tax levy limit calculation which will result in eligible tax payers receiving a refund from New York State.

In closing, I want to again thank our Byron-Bergen learning community for honoring the importance of public education for its children. We will continue to communicate with our legislature and governor, and advocate for what is legally and constitutionally ours.

#### **Board President's Corner**

Spring has arrived! This is the time of year that we finalize our school budget. It is always a difficult process because so many of our calculations and decisions come from projected numbers at the State level. This year, our district has gone from believing that the New York State budget would come in on time, to needing to revisit our numbers when it looked like the budget would not pass. Then, finally, we went back to the numbers recently released from the Governor's office to the school district.

To say the least, it has been a rollercoaster over the last few weeks for us and for school districts across New York State. Our Board of Education, Superintendent, and Business Official, with the input of many others, have worked very hard to put in place a budget we believe is best for our community, our schools and, most importantly, our students. We look forward to seeing you at the May 16 Budget Vote.

I would like to thank all those who came out to vote for the Capital Project. The outcome was certainly not what we had hoped for, but we are taking the community's concerns seriously, and are looking at what we can do differently. We are hopeful that, with some adjustments based on a reassessment of our needs, we will be able to put this project out for a vote in the future, and have a positive outcome.

The Capital Building Project was voted down, but that doesn't mean that the bulk of the work still won't need to be accomplished. Our roofs still need repair, and asbestos has to be removed; kitchen equipment, lights, boilers, the dehumidification system, windows, and fire alarm software all need to be replaced, along with other items that are old and outdated. We need to be ADA compliant, and must continue to make our buildings safe for our staff, faculty, visitors, and children.

The problem with the defeat of any Capital Project is that building projects generate State aid for the school district. It is like using a coupon from the State. In this case, it would have been like getting 86.5 cents off per every dollar spent. Now, if we do these repairs, replacements, and upgrades from our operating budget, the taxpayer pays full price. If you would like to share any thoughts, ideas, or suggestions about this project, please contact any Board of Education member, Superintendent Edwards, or other school official — we would love to hear from you.

Thank you to all of our actors, musicians, backstage crew, and playwright for another successful musical, the original production of "10 (Again)." It is always wonderful to see the talent that lies within our students.

Congratulations to all the students who were inducted into the National Junior Honor Society and National Senior Honor Society this year; and to all the kids who were involved in this year's story telling event. Everyone's hard work and dedication is evident in the number of students recognized and participating. These achievements could not be reached without support from families, faculty, and staff — thank you for all you do.

A huge thank you to our students who continue to give back to those within and outside of our community. Every year, the elementary children work on several areas of community need; this years' girls' soccer program again made a large donation to combat cancer; and our high school student body have worked hard to make the American Red Cross Blood Drive a success. It doesn't take much to make a difference in someone else's life and all involved are wonderful examples of giving to others.

A big welcome back to Roger Caldwell who will be taking over as our new Director of Facilities, effective July 1. His experience and knowledge of our campus make him the perfect person to take over this position. We are very excited to have him back here at Byron-Bergen.

This now leads me to having to say goodbye to the current and long-standing director, Mike List. Mike graduated from B-B in 1978, left for a few years, and then applied for a maintenance position in 1984. After showing what he was capable of doing and working his way up the ladder, he became the Director of Facilities in 1994. There is nothing about this campus that Mike doesn't know. His years of countless hours spent both inside and outside of the school walls cannot be measured by a simple time card: early morning plowing runs, late-night events, and everything in between. #### NYS Property Tax Levy Limit in Brief

NYS has a property tax levy, not a 2% cap which is very confusing. The law does not restrict any proposed tax increase to 2%. The following is our District's calculation for determining the 2017-18 property tax levy limit.

The law creates an 8-step formula to determine the tax levy limit.

• Adjusts tax levy to reflect local growth in the tax base and the rate of inflation (Consumer Price Index [CPI] or a maximum of 2% whichever is less).

Sets a higher threshold for voter approval of budgets IF proposed tax levy increase exceeds the tax levy limit plus exclusions.

• The Board of Education can present a budget that requires a levy that would exceed the limit but we would need 60% voter approval to do so.

The property tax levy limits the school district's levy NOT the individual tax bill of resident taxpayers.

• Assessments and equalization rates will still impact tax rates.

Voters are approving the budget (spending plan), not the tax levy.



### PROPOSED 2017-18 BUDGET "HOW FUNDS ARE GENERATED"



II. LOCAL PROPERTY TAXES  The actual amount of the tax levy is set by the Board of Education in August 2017. We are projecting the tax levy to increase 1.82%.	\$8,377,337	\$8,529,841

V. SPECIAL EDUCATION  This category includes expenses for the Chairperson of Special Education's office, salaries for special education teachers, supplies, contractual, and tuition for out-of-district placements at BOCES and private facilities. To minimize costs for the District, only those students with the severest needs will be placed out-of-district. The District will continue to contract with outside providers for occupational, physical, and vision therapy for students. Costs for BOCES provider services and tuitions are projected to increase \$78,225.	\$2,606,455	\$2,773,138
VI. INTERSCHOLASTIC SPORTS AND EXTRACURRICULAR This category includes expenses for coaches' salaries, official fees, equipment, uniforms, and supplies to support the sports programs. It also includes expenses to support all extracurricular activities such as the marching band, school play, and various clubs. This category includes costs related to the S.O.A.R. (Shared Opportunities and Resources) initiative with the Caledonia-Mumford Central School for football and the restoration of the part-time athletic trainer, \$25,000.	\$415,525	\$452,255
VII. TRANSPORTATION  This category includes all salaries for bus drivers, mechanics, and supervision. Also included are operating expenses such as bus parts, fuel, tires, oil, and equipment to maintain the fleet. VIII. EMPLOYEE BENEFITS  This category contains expenses for the State Retirement systems, Social Security, Workers' Compensation, Unemployment, and health insurance premiums. The Teachers' (TRS) and Employees' (ERS) Retirement systems have contribution rates of 9.8% and 15.8%, respectively. These rates represent decreases from the 2016–17 rates of 11.72% and 18.2%, respectively. Health insurance premiums are increasing approximately 12% for 2017–18.	\$4,294,000	\$4,305,000
IX. DEBT SERVICE This category provides for principal and interest payments on the 2008 Capital Project. It also provides for transportation vehicle purchases.	\$2,911,950	\$2,072,477

The category provides for funds used to cover special education summer school costs at BOCES, not covered by State aid. This category also includes a \$100,000. Capital Outlay Project to address repairs and maintenance needed to our facilities that were identified through the recently conducted Building Conditions Survey.		
The \$100,000 Capital Outlay provides the District with a tool to do preventative maintenance to our facilities on a timely basis. This is a more cost effective process to address repairs before they become major expenses costing the taxpayers more.		
A \$100,000 Capital Outlay Project is subject to all State Education Department approvals, must be designed by a licensed architect, and is subject to Building Aid. Our current Building Aid ratio is 76.5%. The net local cost for the Capital Outlay Project is projected at \$23,500. Capital Outlay projects can be done on an annual basis.

### Our District earns 2017 School Safety Excellence Award

The Byron-Bergen Central School District is one of 136 school districts and Board of Cooperative Educational Services (BOCES) in New York State to receive the Utica National Insurance Group's School Safety Excellence Award for 2017. District Superintendent Mickey Edwards and Jr./Sr. High School Principal Patrick McGee accepted the top, titanium-level award and a \$500 prize, to be used to further safety efforts, on April 21.

"This is an affirmation of all the safety and security initiatives our district has been taking," said Edwards. "Our school resource officer recently completed a district-wide safety audit, and he has made remarkable personal connections with our students and staff. Our culture includes the Olweus Bullying Prevention Program and regular character building events and activities at all grade levels. We have implemented a number of measures, including the New York State Sheriff's Association (NYSSA) Rapid Responder® Program, an all-hazards site-based

crisis management system, and a large security camera system that oversees buildings and grounds. Current security also includes a comprehensive visitor management system in all schools that is used for visitor background checks and ID badges."

"Providing a safe and secure learning environment for our students, teachers, staff, and visitors is our first priority,"

he said. "We are honored to receive this recognition."

The School Safety Excellence Award Program has three levels — titanium, platinum and gold — and annual awards are given based on quantifiable measurements of excellence in categories that include bullying prevention programs, playground safety, and other areas. Utica National has kept children and school staff safe for over 40 years, and currently insures more than 300 school districts in upstate New York alone.

"Safety and health concerns continue to be a priority in our school districts," said Brian Saville, resident senior vice president in Utica National's Educational Institutions Unit. "Districts that go above and beyond to provide a safe, healthy, and focused culture for learning are to be applauded, and we're pleased to count Byron-Bergen Central School District among them."
