Director Of Instructional Services Comments: B. Manfreda and P. McGee attended a conference a few weeks ago which talked about graduation measures for the future. NYS has received feedback about the requirements for graduation and they will be forming a Blue Ribbon Committee to rework the requirements necessary for graduation. The curriculum for K-6 is now aligned per the new state requirements and they are working on aligning science next.

Business Administrator Comments: L. Prinz stated that starting this Monday some employee groups will now be punching in with the new nVision "Timepiece" software. A clock is located in each building. The bus garage breakroom was renovated over the February break with a fresh coat of paint and new flooring. The Maintenance Department will be wearing uniform shirts identifying them as Byron-Bergen Employees. The Governor's budget proposal currently does not include the property relief check that many citizens are used to getting.

L. Prinz presented the first draft of the 2020-2021 budget. This budget includes the Governor's revenue proposal which is low and the hope is that the legislature will convince the Governor to increase Foundation aid for 2020-2021. Two seventy passenger buses will also be up for voter approval to keep on schedule with the replacement plan. The budget hearing will be held on May 12th at 7:00 p.m. in the Jr./Sr. High Auditorium. The budget vote will be held on May 19th from 12:00 p.m. – 9:00 p.m. in the Jr./Sr. High Fitness Room.

Academic Focus:

Lorrie Mallaber and Kelly Stephen, our Reading Recovery teachers, presented on 1st and 2nd grade. They put Board members and attendees in the "shoes of students who have problems reading" to help understand the struggle some students go through. Kelly and Lorrie showcased two students' progress from the beginning of the year until now which showed substantial growth. Kelly and Lorrie talked about how they work individually with students and repetition of reading is key. In a thirty minute session, a student can read as many as six books. Also discussed was, the "summer slide" where kids can lose significant knowledge in reading and math over the summer without continual practice.
