PROPOSED BUDGET \$25,972,402

TAX LEVY INCREASE 0.44% over the current year

WHAT IS ON THE BALLOT?

Voters will consider the following separate propositions on the ballot:

Proposition #1 – School Budget

The School will be authorized to expend the sum set forth in its estimate of expenditures for the 2023-24 school year in the amount of \$25,972,402 and to levy the necessary taxes therefore.

Proposition #2 – School Vehicle Replacement

The School will be authorized to spend up to \$283,421 to purchase and replace school buses and vehicles. With more students requiring educational placements outside of the Byron-Bergen District, we are in need of smaller, more fuel-efficient vehicles to transport these students.

Proposition #3 – New 2023 Capital Reserve to Replace Old 2019 **Capital Reserve**

The School would be authorized to create a new "Capital Reserve Fund-2023" to replace the old "Capital Reserve-2019" with a maximum threshold of \$4,000,000. This reserve has a life of 15 years and can be funded over that lifetime and be used to set monies aside for future capital projects. Currently, starting with the year 2027 schools will be required to purchase zero emission school vehicles. If this requirement does not change, we will need to purchase and install infrastructure to transition our fleet to be compliant. Any monies remaining in the existing 2019 Capital Reserve account will be transferred to the new 2023 Capital Reserve.

Proposition #4 – New 2023 Technology and Equipment Reserve

The School would be authorized to create a new "Technology and Equipment Reserve Fund- 2023" with a maximum threshold of \$2,000,000. This reserve has a life of 15 years and can be funded over that lifetime and be used to set monies aside for future replacement and upgrading of our mass notification, cameras, secure door entry systems and equipment.

BOARD OF EDUCATION ELECTIONS:

There are two full term (three year) Board seats and one partial (13.5 month) Board seat up for election this year, commencing in July 2023. Interested voters will select from the following candidates at the polls: Lisa Forsyth, Amy Phillips, Lynn Smith, and Cindy Matthews.

Three part budget expenditures

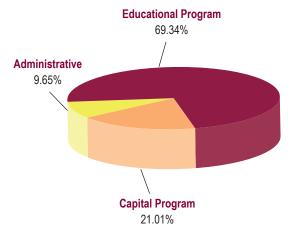
New York State law requires that school districts present the proposed budget in three parts: administrative, educational program and capital.

Administrative component – includes expenses for the Board of Education, central administration, instructional supervision, curriculum development, legal services, central data processing, printing, mailing, storage and employee benefits attributable to salaries included in these functions.

Educational program component – includes expenditures for instructional programs, school library/ audiovisual, attendance, counseling, health services, interscholastic athletics, student transportation, transfers to special aid fund and employee benefits attributable to salaries included in these functions.

Capital component – includes expenses for operations and maintenance, grounds, security, utilities, principal and interest payments for debt service, transfers to capital fund and employee benefits attributable to salaries included in these functions.

The 2023-24 general fund proposed budget includes a capital outlay project at the Jr/Sr High School Building. This project will include the replacement of exterior and interior doors, door hardware and card reader systems. The total cost of the project will not exceed \$100,000 and is aided through NYS building aid. By completing this work in the 2023-24 school year, the District will receive the NYS building aid in the subsequent year.

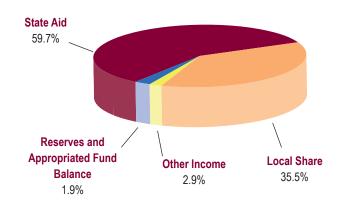

The major sources of projected revenue for the 2023-24 school year are shown in the graph. State and Federal aid accounts for 59.69 percent of revenues. The local share, which represents local property taxes and STAR, accounts for 35.51 percent of revenues. District income, which represents all other sources of revenue, accounts for 4.8 percent of revenues.

School bus proposition

The district will have a proposition to purchase replacement school buses on the ballot on May 16, 2023 in an amount not to exceed \$283,421. The proposition includes the purchase of two (2) mini buses and three (3) minivans. With this purchase of school vehicles, the district will continue to have a fleet of vehicles on a nine year replacement schedule.

Byron-Bergen is receiving approximately 90% State transportation aid on our 2023-24 school bus purchase. If the aid ratio remains the same for these two new buses and minivans, the district would receive \$255,079 in aid. The remaining \$28,342 would be local share responsibility.

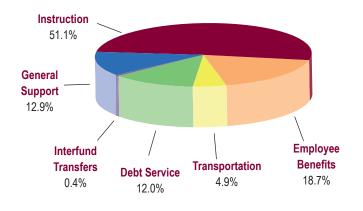

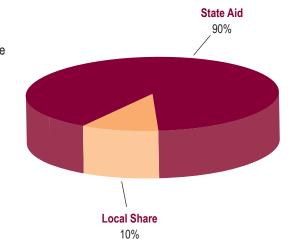

The 2023-24 tax levy amount would remain the same as the 2022-23 actual tax levy amount and the 2023-24 proposed budget must be adjusted to reflect the reduction in tax collection. The 2023-24 budget reductions include the elimination of all equipment purchases (per Education Law), elimination of public newsletters and reduction in postage, elimination of Alumni Hall of Fame Inductee program, elimination of open weight room for students, elimination of some BOCES services, reduction in staff development, and reduction in building insurance coverage.

4 Byron Bergen Focal Point

Answering your tax-related questions...

- Q. What is Byron Bergen Central School's budget for next year?
- **A.** The proposed budget for the 2023-24 school year is \$25,972,402. This represents a budget-to-budget increase of 1.76%.
- Q. Were any programs or staff cut in the 2023-24 proposed budget?
- A. No, the school is receiving additional State Aid this year, no cuts were made.
- Q. What is Byron Bergen's allowable tax levy limit?
- A. Under the law, Byron-Bergen can establish a maximum tax levy limit increase of 0.44% for a simple majority vote. With the promised increase in State Aid funds, the District will be able to balance our 2023-24 budget. The 0.44% increase in the tax levy is a total increase of \$40,278 or a \$0.03 increase in the 2022-23 tax rate. For a home assessed at \$100,000 this would result in approximately \$3.00 increase in taxes for the 2023-24 school year.

Q. Why is the budget increasing 1.76%?

- A. The majority of the spending increase is resulting from increases in health insurance premiums, increases in utility costs, addition of BOCES services, purchases of equipment and contractual pay increases.
- Q. Why is the District looking to purchase 2 mini buses and 3 minivans?
- A. With an increase in the number of our students having educational placements outside of our school district, we are looking to reduce transportation costs. Purchasing smaller transportation vehicles which are lower in cost and more fuel efficient will enable us to do so.

Q. Why is the School presenting Proposition #3 asking for the voters to establish a new reserve fund titled "Capital Reserve Fund-2023"?

A. In October 2021, district voters authorized the 2021 capital project and the use of \$2,000,000 in the Capital Reserve-2019 to be used towards the cost of the 2021 capital project. With this approval, going forward, the Capital Reserve-2019 can no longer be funded with any excess funds remaining at the end of each school year for future capital projects. In order to start saving excess funds for a capital project in future years, we are asking the voters to approve the creation of a new Capital Reserve fund titled "Capital Reserve Fund-2023". The life of this reserve is 15 years and the reserve cannot be funded more than \$4,000,000 over that same time frame. One potential future use of such a capital reserve may be to purchase and install infrastructure to meet the New York State mandated zero emission vehicle requirements. With the current NYS mandates, schools will only be able to purchase zero emission vehicles starting with the 2027 year and must be 100% zero emission by the year 2035. If these mandates do not change, the School will need to purchase and install infrastructure to operate and maintain a zero emission fleet.

- Q. Why is the school presenting Proposition #4 asking for the voters to establish a new reserve fund titled "Technology and Equipment Reserve Fund-2023"?
- A. A few years ago the District received and used SMART Bond monies, made available from NYS, to purchase and install our mass notification system, new security cameras and enhanced secure entryways at both the Elementary and Jr./Sr. High School for safety and security within the buildings. It is anticipated that the new technology may need updating or replacing within the next 7 to 10 years. The creation and ability to fund a Technology and Equipment Reserve Fund-2023 would provide the District with a savings account which could be used to add to, replace, and upgrade this technology when needed. The life of this reserve is 15 years and the reserve cannot be funded more than \$2,000,000 over that same time frame. This maximum funding threshold has been based upon the original cost of the safety and security work already done.

Q. Is the STAR program still in effect?

A. Yes, the STAR program is in effect. The STAR exemption is a reduction on your school tax bill for homeowners who participated in the STAR exemption program prior to 2015 and continue to meet the eligibility requirements. For the Basic STAR exemption, the homeowner will see a reduction of \$30,000 in taxable assessed value. For the Enhanced STAR exemption, the homeowner will see a reduction in taxable assessed value of \$81,400 for residents of the Towns of Batavia, Bergen, Byron, Clarendon, Elba, Riga, Stafford, Sweden and \$67,560 for residents of the Town of LeRoy

The STAR credit check is for eligible homeowners since 2015 and after. If you purchased your primary residence after August 1, 2015 and your income is \$500,000 or less, you will receive a STAR check in the mail each year. For the STAR credit check method only, STAR exemption amounts may be increased by New York State by 2% or less each year.

Q. How do new homeowners apply for their STAR benefit?

A. For homes purchased after August 1, 2015 the homeowner will need to register for the STAR credit through New York State rather than applying with your assessor. For these homeowners, a STAR credit will be received in the form of a check from New York State directly.

Q. Am I eligible for the Enhanced Star benefit?

A. If you own your home and it is your primary residence, are age 65 by December 31, 2022 and your income is \$93,200 or less, you are eligible for the Enhanced STAR benefit. Go to www.tax.ny.gov for more information.

Q. What affect does an increase in property assessments have on my school taxes?

A. Increases in property assessments can cause an increase in your tax bill to be greater than the proposed 0.44%. Please note, the school is not involved in any increases/decreases with your property assessment. If you have any questions with regard to your assessment or need any information changed on your tax bill, you need contact your town tax assessor.

Estimated Tax Information

Homeowners are eligible for tax relief under New York State's Tax Relief Program (STAR). Upon application, homeowners may be eligible for up to a \$30,000 decrease in their assessment. Senior citizens (age 65 and older) may be eligible for an Enhanced STAR reduction of their assessment in the amount of \$81.400 for residents of the Towns of Batavia, Bergen, Byron, Clarendon, Elba, Riga, Stafford, Sweden and in the amount of \$67,560 for residents of the Town of LeRoy. The STAR exemption is authorized by section 425 of the Real Property Tax Law.

What will you see at the polls?

Proposition #1 - RESOLVED that the proposed budget of expenditures of the Byron-Bergen Central School District for the school year 2023-24, totaling \$25,972,402 and for the purposes shown in the statement of estimated expenditures adopted by the Board of Education, be and the same hereby is approved and the amount thereof shall be raised by a levy of a tax upon the taxable property of the school district, after first deducting the monies available from State aid and other sources as provided by law.

Proposition #2 – RESOLVED that the Board of Education of the Byron-Bergen Central School District is hereby authorized to acquire two (2) mini buses and three (3) minivans at a cost not to exceed \$283,421, which is estimated to be the maximum cost thereof, expend such sums for such purpose, levy the tax necessary therefore, to be levied and collected in annual installments in such years and in such amounts as may be determined by the Board of Education, taking into account State aid received, and in anticipation of the collection of such tax, to issue bonds and notes of the District at one time or from time to time, or enter into a lease-purchase agreement to acquire said vehicles.

Proposition #3 – RESOLVED, that the Board of Education of the Byron-Bergen Central School District, Genesee, Monroe and Orleans Counties, New York (the "District") is hereby authorized and directed to

(a) establish a reserve fund pursuant to Education Law Section 3651 to be known as the "Capital Reserve Fund-2023" for the purpose of financing, in whole or in part, additions, alterations, renovations or other improvements to existing District's buildings and facilities, construction of new buildings or facilities or the acquisition of lands or interests in lands for District purposes, including the construction, reconstruction or improvement of playgrounds, athletic fields, recreation areas, parking areas, roadways, sidewalks and other site improvements connected to such buildings and facilities, and the acquisition and installation of machinery, equipment, apparatus or furnishings required for the purposes thereof, with the ultimate amount of such reserve fund not exceeding four million dollars (\$4,000,000), plus any accrued earnings on amounts deposited in such reserve fund, the probable existence of said reserve fund being fifteen (15) years, but said reserve fund to continue in existence for its stated purpose until liquidated in accordance with the Education Law, and the sources from which funds shall be obtained for said reserve fund being (i) current and future unappropriated fund balances from the General Fund of the District, as directed by the Board of Education, (ii) appropriations authorized by the voters from time to time, (iii) fund balances transferred from other reserve funds of the District as may be authorized by the Board of Education or by the voters of the District from time to time in accordance with applicable State law, and (iv) state aid, as directed by the Board of Education from time to time; and

(b) transfer to said capital reserve fund the entire balance on deposit in said District's existing "Capital Reserve-2019" established pursuant to Education Law Section 3651 pursuant to a proposition approved by the qualified voters of said District on May 21, 2019.

Proposition #4 – RESOLVED, that the Board of Education of the Byron-Bergen Central School District, Genesee, Monroe and Orleans Counties, New York (the "District") is hereby authorized and directed to establish a reserve fund pursuant to Education Law Section 3651 to be known as the "Technology and Equipment Reserve Fund-2023" for the purpose financing, in whole or in part, the purchase of technology equipment, including hardware and software, related devices, networking equipment, peripherals, and other equipment (educational and office), machinery or apparatus incidental thereto or separately, provided that such capital costs are an object or purpose that would be eligible for financing under the Local Finance Law, the ultimate amount of such reserve fund shall not exceed two million dollars (\$2,000,000), plus any accrued earnings on amounts deposited in such reserve fund, the probable existence of said reserve fund being fifteen (15) years, but said reserve fund to continue in existence for its stated purpose until liquidated in accordance with the Education Law, and the sources from which funds shall be obtained for said reserve fund being (i) current and future unappropriated fund balances from the General Fund of the District, as directed by the Board of Education, (ii) appropriations authorized by the voters from time to time, (iii) fund balances transferred from other reserve funds of the District as may be authorized by the Board of Education or by the voters of the District from time to time in accordance with applicable State law, and (iv) state aid, as directed by the Board of Education from time to time.

Board of Education Candidates

The election of two (2) Board of Education trustees, with the highest number of votes, will be appointed for a three year term and one (1) Board of Education trustee, with the third highest number of votes, will be appointed to fill the Board seat vacated by William Forsyth for the term of May 17, 2023 through June 30, 2024.
